Newsletter-Privacy/Policy

Information regarding the EU 2016/679 regulation on personal data protection (“GDPR”)

According to art. 13 of the GDPR, the University of Helsinki, in the quality of controller, informs you that your personal data, provided by you at the time of your registration to the informative newsletter ([https://riscape.eu/or by MailChimp](https://riscape.eu/or%20by%20MailChimp)), will be subject to treatment as established by the applicable normative and according to principles of fairness, transparency and care for your privacy and your rights.

CONTROLLER OF TREATMENT

The Data Protection Office ("DPO") for the data treatment is the ICOS ERIC, Erik Palmenin aukio 1, 00560 Helsinki (“Controller”).

TYPE OF TREATED DATA

The data treated by the holder/controller will be the ones you will provide at the time of registration and specifically: name, surname, e-mail.

AIM OF DATA TREATMENT

The treatment of data is aimed at sharing information and news related to the RISCAPE project activities.

LEGAL BASE FOR TREATMENT OF DATA

The legal base on which data treatment is conducted is the consent given by the interested party in the possibility of using their data for one or multiple finalities. (art. 6 provision 1, lett. a) of GDPR).

MODALITIES AND CONTEXT OF TREATMENT

Treatment will occur through the registration on our website [<https://riscape.eu/>], via MailChimp, or via paper copy registration at conventions or events where personal data are provided through typing them into one or multiple automatized systems of internet-connected personal computers or centralized consortium systems.

Your personal data will be used exclusively by authorized personnel who received thorough instructions prior to handling your data as well as by the authorized processors of treatment linked to the holder/controller as per contract.

Some contact details, in particular the e-mail addresses used for the newsletter are automatically transferred to the Mailchimp software databases, on servers located in the USA; Mailchimp adheres to the Privacy Shield (the US-Europe transfer guarantee framework), and ensures full possibility of unsubscribing from newsletter lists. RIGHTS OF THE INTERESTED PARTY

You possess the following rights:

- Right to access your personal data;
- Right to alter or delete your data or limit the treatment of your personal data;
- Right to data portability, when required;



- Right to revoke consent, when allowed; revoking consent does not hinder the lawfulness of the data treatment based on consent given prior to the cancellation; following revocation is the impossibility to use your data and continue with telematic registration; revocation is not possible in cases where data treatment is required by norm to which the holder/controller is subject
- Right to file a complaint to the controlling authority (Garante Privacy).
